1.0 Introduction

- 1.1. The Equality Act (2010) places a duty on all public authorities in the exercise of their functions to have regard to the need to eliminate discrimination, to advance equality of opportunity and to foster good relations between persons who have a “protected characteristic” and those who do not.
- 1.2. ‘Protected characteristics’ are age, disability, gender reassignment, marriage & civil partnership, pregnancy and maternity, race, religion or belief, sex, and sexual orientation.
- 1.3. This report assesses the Submission version of the Cliddesden Neighbourhood Plan (CNP) to ensure that Cliddesden Parish Council (as the qualifying body responsible for preparing the CNP) is satisfying its statutory duties in this regard. Equality Impact Assessment (EqIA) is a systematic analysis of a policy or policies, in order to explore the potential for an adverse impact on a particular group or community. It is a method of assessing and recording the likely differential and/or adverse impact of a policy on people from different groups. If a policy results in unfairness or discrimination, then changes to eliminate or lessen the impact should be considered.
- 1.4. The purpose of the analysis is to increase participation and inclusion, to change the culture of public decision-making and to place a more proactive approach to the promotion of equality and fairness at the heart of public policy. The processes involved in conducting the analysis should not be looked on as an end in themselves. Instead, it should be borne in mind that the aim is the promotion of fairness and equality of opportunity and thus it is the outcomes that are of primary concern. In undertaking the EqIA, it is important to keep in mind why the CNP is needed, what the intended outcomes are, and how it will be ensured that the policies will work as intended.
- 1.5. Basingstoke and Deane Borough Council is required to undertake EqIA of its policies, plans and strategies to ensure that they do not discriminate against any group or individual in the community. The duty to undertake EqIA arises from the Race Relations (Amendment) Act 2000. Following the referendum of the CNP, Basingstoke and Deane Borough Council will formally ‘make’ or adopt the plan as part of the Council’s Local Development Plan. As such, the policies within the CNP must be subject to an EQIA.

2.0 Methodology

- 2.1. An assessment has been made on whether the CNP has a positive, negative or neutral impact on each of the protected characteristics (in so far as data is available). The vision and objectives of the NP have been assessed, and individual policies are highlighted where they are considered likely to have a negative impact.

3.0 Baseline data

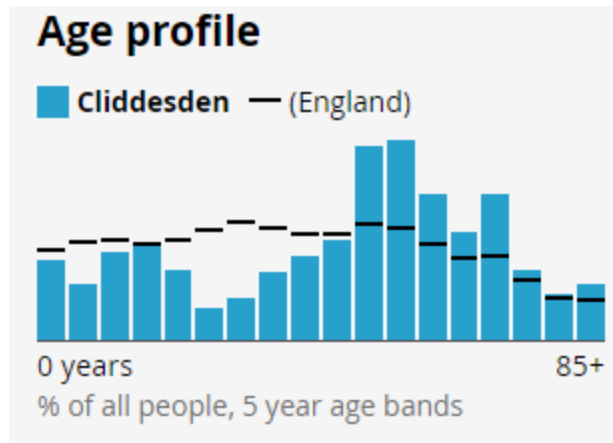
- 3.1. Data for the Parish of Cliddesden is available from the 2021 Census for the following protected characteristics: age, sex, disability, legal partnership status, ethnic group and religious belief.
- 3.2. No data is available for the following protected characteristics: gender reassignment, pregnancy and maternity and sexual orientation.

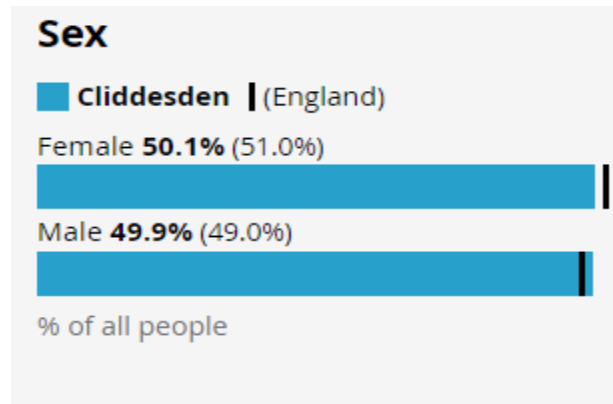

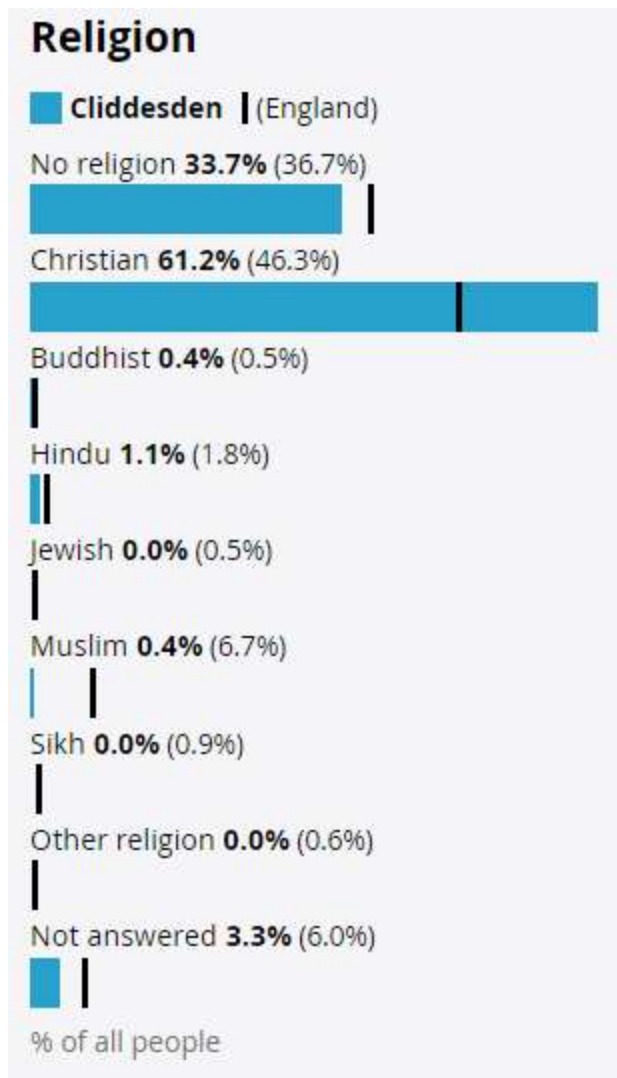

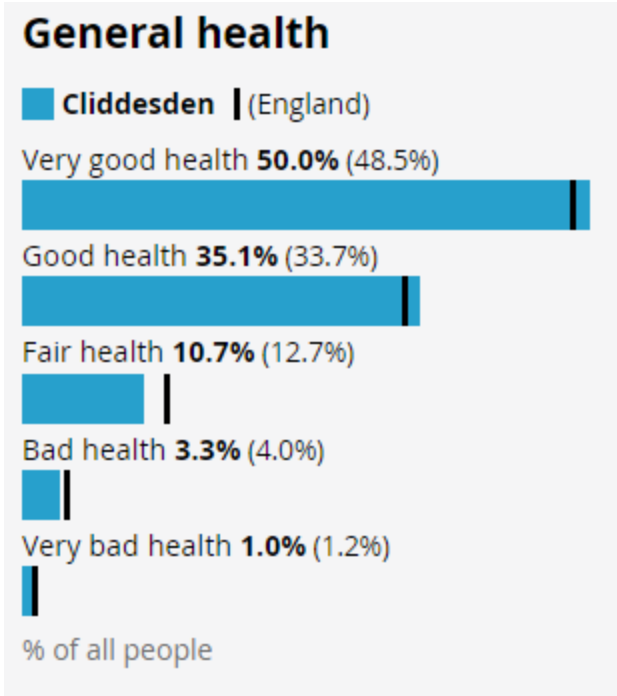

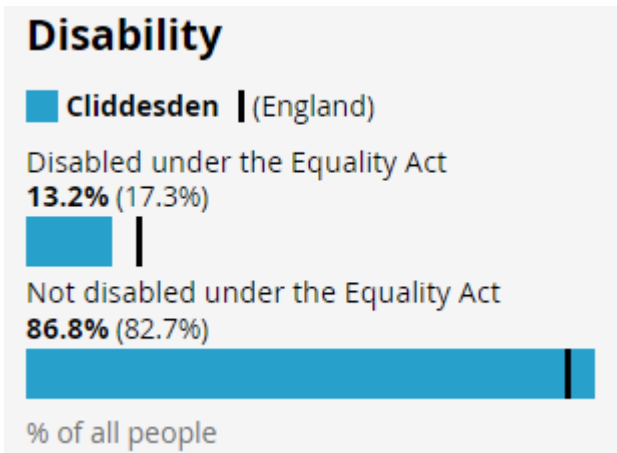
Legal partnership status



Health: The local community is generally healthy, with 85.1% reporting 'Very good' or 'Good' health at the time of the 2021 Census. 10.1% reported their health to be 'fair' 3.3.% reported their health status as 'bad' and 1% as very bad

4.0 Process of Community Consultation

- 4.1. All written communications were in English, and it was not considered necessary to translate them into any other language given that 99.2% of households spoke English as their main language.
- 4.2 Throughout the plan preparation process, the Neighbourhood Plan Working Group has sought to ensure that local residents, their representatives, local businesses, interest groups and wider interested parties, including statutory and regulatory bodies, have been actively consulted and their views sought.
- 4.3 Agendas, key reports and updates have been regularly provided online on the Cliddesden Neighbourhood Plan website.
- 4.4 The overarching principles of the stakeholder engagement process has been to engage in a manner that is extensive, effective, inclusive, fair, transparent and proportionate.
- 4.5 Widespread consultation was carried out during the preparation of the Neighbourhood Plan and the Working Group made every effort, using a variety of methods, to reach all of the local community.
- 4.6 A considerable number of community consultation exercises, including questionnaires and public meetings, were carried out between 2018 and 2022, when the CNP was progressing.
- 4.7 The process of community engagement began with a review of existing evidence and other local documentation to establish an understanding of the key issues which faced Cliddesden. This process would assist in the development of a draft vision and objectives for the CNP. The steering groups carried out a thorough review of available material to develop a good understanding of local issues and aspirations.
- 4.8 A series of non-statutory consultations took place in the development of the CNP leading up to the formal regulation 14 consultation. The first formal public consultation event was the Neighbourhood Plan open day which was held from 11.00 to 15.00 on the 24th of November 2018 in the Cliddesden Village Hall. Residents and visitors were invited to attend this inaugural event which set out to engage as wide an audience as possible in the development of the CNP. The event was advertised to the wider community and open to all.
- 4.9 Following the successful Open Day, the CNP Steering group wanted to maintain the momentum and interest in Neighbourhood Plan development. Through a series of Steering Group meetings, the group concluded that the most effective next step would be to carry out a community wide questionnaire. Four copies of the questionnaires were distributed by hand to each household and one copy to each business with a covering letter outlining the purpose of the questionnaire. Paper copies of the questionnaire could be returned by freepost, or the survey completed on-line and links to the questionnaire on SurveyMonkey were also given on the Cliddesden Neighbourhood Plan website, and Facebook page. The intention of circulating multiple questionnaires was to encourage responses from younger people, as the group understood they would be less likely to engage.
- 4.10 To ensure all sectors of the community had a chance to influence the development of the CNP the steering group prepared an interested parties' questionnaire. The questionnaire was circulated to a range of organisations, businesses and landowners within the Neighbourhood Plan Area the end of February 2020. Whilst these groups and organisations would not

necessarily include individuals with protected characteristics, we were aware that some organisations would be working with or supporting individuals with protected characteristics, and it was important to reach out to those individuals through this exercise

- 4.11 Following the interested parties' questionnaire the CNP team launched the issues and options consultation. The consultation was originally envisaged as an open day format, however due to Covid 19 restrictions, the CNP team decided to deliver the consultation in a questionnaire format, making the questionnaire available both online and via paper copies. The CNP team was initially concerned about being unable to run a face-to-face consultation, as they felt this would be more open and encourage more engagement from a wider audience. However, the volume of responses and both volume and content of comments on the consultation indicates that the format was very successful.
- 4.12 The final stage in the consultation process was the preparation and publication of the Pre-Submission Plan and supporting evidence base. These materials were published on Tuesday 15th February 2022 for a period of 6 weeks to Wednesday 30th March 2022. The Pre-Submission consultation has been advertised widely and we have encouraged all sectors of our community to respond and engage. There were 124 responses from a wide range of people across the age ranges and representing people from across the parish.

5.0 Likely Impacts on Groups with Protected Characteristics

- 5.1 This EIA has been produced to assess the implications of policies included in the Regulation 14 or consultation draft of the Cliddesden Neighbourhood Plan. This has been produced using guidance on the Equality and Human Rights Commission and Department of Communities and Local Government websites.
- 5.2 The following Tables assess the Plan's policies for their likely impact on the protected characteristics; positive, neutral, or negative impacts are noted. Where an impact is positive or neutral, no change will be made to the policy. Where a negative impact is noted, a grading is assigned; 'high' means that mitigation is unlikely to overcome the issue; 'medium' means that future or existing mitigation could overcome the issue; 'low' means that the issue is judged insignificant. The results of this assessment may lead to final changes prior to submission or inform suggested changes at a later stage by the examiner.
